

A Message from the Council by Mr. Hill :

Mr. Speaker,

The Council have agreed to fourteen Resolutions of this House for granting the following sums, viz:

- £35 to J. J. Sawyer,
- £100 for Sundries for the Council and the Assembly,
- £30 for Stationary for the Council, &c.
- £1557 10 for the encouragement of Agriculture,
- £250 for making Rooms over the Court-House,
- £20 to Abel Benjamin,
- £200 for a Salary to the Secretary and Treasurer of the Central Board of Agriculture.
- £10 to the Messenger of the Council,
- £70 for extra Clerks to the Council,
- £15 5 3 to William A. Black, and others,
- £100 to Eliza Monk,
- £295 19 11 for repairs to the Government-House.
- £97 1 11 for repairs to the Province Building,
- £2000 for a Bounty upon Salt.

The Council have agreed to the Resolution of this House relative to the appropriation of £150 for Roads in the County of Shelburne.

The Council have agreed to a Bill, entitled, An Act to alter the Times of sitting of the Inferior Courts of Common Pleas and General Sessions of the Peace in the Counties and Districts therein named, without any amendment.

The Council have not agreed to the Resolution of this House relative to the Pay of the Members. And then the Messenger withdrew.

On motion of Mr. Haliburton, *resolved*, That a Committee be appointed to wait upon His Excellency the Lieutenant-Governor, with the copy of the Resolution for granting the sum of One Hundred Pounds to Mrs. Eliza Monk, in answer to her Petition, sent by His Excellency, for the consideration of the House; also, with a copy of the Resolution granting the sum of One Thousand Pounds to be expended in the erection of Stone Bridges on the main Post Roads in the Province; and also, with copies of the several Resolutions appropriating Monies for various services in the Island of Cape Breton.

Ordered, That Mr. Haliburton, Mr. Uniacke and Mr. R. Dickson, be a Committee for the above purpose.

On motion, the House resolved itself into a Committee of the whole House to consider further of a Supply.

Mr. Speaker left the Chair,

Mr. James took the Chair,

Mr. Speaker resumed the Chair.

The Chairman reported from the Committee that they had gone through the business to them referred, and that the Committee had framed a Bill for applying such part of the Supplies granted in this Session of the General Assembly as are not already appropriated by the Laws or Acts of the Province, which they had directed him to report to the House, and he afterwards delivered the Bill in at the Clerk's Table; and thereupon,

On motion, the said Bill was read throughout a first and second time, and thereupon,

Ordered, That the Bill be engrossed.

On motion, *resolved*, That a Committee be appointed to wait upon His Excellency the Lieutenant-Governor, to inform His Excellency that the House will be ready to be prorogued To-morrow, if it should suit His Excellency's convenience.
