

ANONYMOUS LETTER WRITERS ALSO LET LOOSE ON THE CITIZEN CANDIDATE.

The London Free Press, in its despairing campaign in the interests of the Toronto candidate for the representation of London, has within the last day abused the London citizen candidate in unstinted terms. When it finds its editorial stock of denunciation running down it transfers its efforts to that last resort of the uncourageous-the anonymous letter-and it belabors Mr. Hobbs there. All right. Such tactics apparently give satisfaction to this London journal, which is so very anxious to work for the success of the salaried officer of a rival city. But we tell it that its methods help rather than mar the prospects of Mr. Hobbs, who cares not a whit whether the Free Press callshim a paraile logram or a "phenomenon," so long as he is assured that the large majority of his fellow citizens mean to place him in a position where he can do even more effective service for the promotion of the interests of this splendid trade center than it has hitherto been possible for him to accomplish, working though he has been for years past in promoting the commercial and industrial development of London on every occasion possible. While Mr. Hobbs has been building up London, and is desirous by his presence in the Legislature to still further promote her welfare-while the Free Press has been abusing and belittling this progressive London wholesale merchant and manufacturer-where stands his opponent in this contest? He is the paid officer of our rival city. He is pledged to work for Toronto. He never comes to London except to carry money away from it to invest in Toronto property or to spend with Toronto storekeepers. Surely the contrast between the position of the two candidates is so marked that a London journal should be above taking up the arms of abuse and misrepresentation to promote the candidature of the Toronto corporation counsel in preference to the London merchant and manufacturer. WHO FIRED IT?

The Parkhill Merchant, Short, on Trial for Arson.

The Evidence of Johnston-Short Accused of the Deed-A Remarkable Story-Middlesex County

Court.

TUESDAY AFTERNOON. The entire afternoon was taken up with the case of Tunk vs. Bowman, the jury giving a verdict for the plaintiff for \$138. WEDNESDAY MORNING.

The court room was crowded at 10 o'clock this morning, when James B. Short was placed in the dock on the charge of having set fire to his shoe store in Park-

Alex. McTavish, solicitor, of Parkhill, was the first witness. He had an office over Short's store at the time of the fire. There had been a fire in the building on Dec. 26, 1893, which was supposed to have been incendiary. He had issued the warrant for Short's arrest on statements which James Johnston had made. At that time the witness was acting for Mr. Lowden, of Parkhill, against whom the prisoner had issued a writ for \$1,000 for alleged slander in accusing him (Short) of trying to set fire to the store.

JAMES JOHNSTON. When Johnston was called there was a stir in the court room, as it was mainly on his evidence that Short was sent for trial. He told his story in a curt manner, and cross-questioning did not shake him in the least. On the Sunday evening previous to the blaze he had taken a walk with Short. While they were strolling about Short told him that he wanted to get rid of the building, as he making no money out of the business, He offered \$10 or \$15 to any person who would set the place on fire. "On my refusing to set fire to the shop," said would do the job. I told him I did not think he would. On the following morning Downey, Short and myself were in the store. The court then adjourned.

Before Short was removed to his cell he was surrounded by about 25 friends who shook hands with him. The grand jury returned a true bill against James Hobbins and Hugh Semple for highway robbery.
