Polls 4411-2 Votes to Wilson's 324, Harmon and Underwood Trailing.

### ONE VOTE FOR "PEERLESS ONE"

Convention Hall Plunged Into An Uproar When Bryan Moves Sensational Resolution.

[Canadian Press.] Baltimore, June 28 .- The official result of the first ballot for the presidential nomination was: Clark, 4411/2; Wilson, 324; Harmon, 148; Underwood, 1171/2; Marshall, 31; Baldwin, 22; Sulzer, of New York, 2.

Necessary to a choice, 728.

Baltimore, June 28. - At 6 o'clock this morning the Democratic national convention was still listening to nominating and seconding speeches on presidential candidates-Messrs. Underwood, Clark, Wilson, Harmon, and Governor Marshal, of Indiana, had been placed before the convention, and only seconding speeches remained to be heard before the. first ballot was taken.

The convention has been in session since 8 o'clock last night. The delegates were many of them asleep in their seats, the galleries were all but empty, the policemen wide-eyed and weary, but the flood of oratory went on.

Baltimore, June 28.—Chairman James at 6:43 ordered the first roll call on the presidency. Baltimore, June 28. - After sitting all through the night, the Democratic national convention reached the first ballot on the presidential nomination shortly before 7 o'clock this morning. There was no choice. In fact, all of the candidates were so far away from the two-thirds vote necessary to nominate that the delegates today looked forward to a long, hard fight.

After the first ballot the convention at 7:16 a.m. took a recess until 4 o'clock this afternoon. In the meantime there will be much studying of the figures on the test vote and many conferences among the leaders. Champ Clark Led.

As was expected, Speaker Champ Clark led all of the other candidates on the first ballot. He received 4401/2 votes to 324 for Woodrow Wilson, his nearest rival. This, however, left the Speaker 2861/2 votes short of the necessary two-thirds. Governor Judson Harmon, of Ohio, aided by New York's solid block of 90 votes, was third, with 148. Representative Oscar W. Underwood, of Alabama, received

Bryan had no word to say today on the first ballot cast for the presidential nomination by the convention, and after the adjournment of the all-night session, the Nebraskan hurried to his hotel where he retired for a needed rest. He indicated that the delegates had already spoken their mind against Underwood, but was non-committal as to whether his choice was Clark or Wilson, although he added that he had voted for Clark.

Mr. Bryan believes that he has achieved a great moral victory in seachieved a great moral victory in securing the passage of his Morgan-bath afternoons, and travelled to and bath afternoons, and travelled to and from that village by that route.

## STREET RY. MEN LOSE THEIR JOBS

Three Employees, It Is Said, Were Dismissed, Because They Were Agitating

TROUBLE OVER WAGES

It is Said That There is Some Talk of Are Not Reinstated.

Employees of the street railway company are holding an indignation meeting this afternoon to consider what further action will be taken concerning the request which they submited a fe wdays ago, asking for an increase in the scale of wages paid, particularly to relief men.

It is declared by certain of the men most prominent among the employees that a strike is imminent, and that while they are prepared to accept reasonable treatment, they will not continue under present conditions.

The dismissal of three of their number this morning because of the fact that they were looked upon as agitators, it is alleged, has also created much dissatisfaction, and the immediate reinstatement of the trio is to be

asked for, it is claimed.

A Secret Meeting.

The matter was thoroughly discussed by a number of the employees who congregated about the corner of Dundard Flighth streets opposite the das and Elizabeth streets, opposite the London street railway offices, this morning, and before noon the fact that a general indignation meeting was to be held this afternoon was quietly spread to all motormen and cinductors. The location of the meeting-place was kept erligiously secret out-side of those directly interested. Superintendent Young, of the street

superintendent Young, of the street railway company, who is accused by the men of having taken possession of their petition for increased remuneration, before they were prepared to present it to the management, declared that the company does not anticipate

tion, before they were prepared to present it to the management, declared that the company does not anticipate any serious difficulty.

The company in January last, having consideration for the fact that the cost of living has greatly increased, raised the scale to 16, 18, 19, 29 and 22 cents an hour, and is therefore unable at this time to make further concessions, said Mr. Young. No arrangements for the future were made at that time, and no promises are to be made to the men in the present difficulty.

All Are Interested.

While the men assert that all are directly interested in the agitation for better pay, and that every motorman and conductor will abide by the decision of their committee, the street railway officials claim that at the time of the last strike of the regular men the spare men filled the vacancies, and that as a result the is some ill-feeling now and that the reinstated regulars will not interest themselves.

### CHARGE AGAINST FARMER SPEEDILY WITHDRAWN

### INJUNCTION REFUSED IN UNION LABEL CASE

Rivalry Between Garment Workers' Unions-Dispute of International Interest.

A case of international interest is that of Rickert vs. Britton In single court at Osgoode Hall yesterday before Mr. Justice Kelly, the plaintiff, representing the United Garment Workers of America, moved for an injunction to restrain defendants from on the ground of the similarity of the labels. The defendants are a London firm, who manufacture garments such

injunction, dismissing the motion with costs payable by the plaintiffs forthwith. A motion by defendants for an order that plaintiffs give security in \$1,000 for cost of action, was dismissed with costs in the cause.

The case derives its interest from the rivalry of two labor organizations, the one international, the other purely Canadian. The United Garment Workers of America are affiliated with the American Federation of Labor: United Garment Workers of Canada with the Canadian Federation of La-
