SCATHING CRITICISM

Conservatives and Liberals Unite in Denouncing Report on Trent Valley Canal.

[Special to The Advertiser.] OTTAWA, June 7 .- A condemne was himself condemned in Parliament Saturday.

G. Howard Ferguson and the report which he made upon the Trent Valley Canal were denounced by Liberal and Conservative members. The man who broke the law of the land to muck-rake the canal construction and who had to have an emergency law enacted at an all-night sitting of the Legislature to clear him, found no friends in Parliament.

Not since F. B. Carvell drove the Hon. A. B. Morine out of Canadian public life with a speech or since Hon. G. P. Graham pilloried Gutelius and Staunton for their Transcontinental report, has a royal commissioner of the Borden Government been the object for such censure as was passed upon G. Howard Ferguson.

The Government has been unfortunate in its choice of scandal-hunt-They have not found scandal, but they have made it.

To Shame of Country.

"It is to the shame of our country that such a man remains in public life," was the comment of Mr. Gau-yareau upon Mr. Ferguson. "The whole conduct of the man appears to have been gravely reprehensible and embued with distorted partisanship," said Hugh Guthrie. "His findings are largely both unwarranted and untrue, and in many cases are disproven by the evidence itself. He has submitted a strangely perverse report which apparently is deliberately untruthful." D. D. These words of reproach were all from the Liberal side, but Conservatives failed to give the report of Mr. Ferguson their support.

Honest Man Accused.

Hugh Guthrie said that Mr. Ferguson had made grave charges against William Hewitt, superintendent at the Hawk Lake Dam. "All that I have been able to learn concerning this man shows him to be both honest and efficient," said Mr. Guthrie.

"There is no better man and none more honest," said Col. Sam Hughes, emphatically. "I believe that," said Mr. Guthrie, "but here is what Royal Commissioner Ferguson says of him." Mr. Guthrie then read from the Ferguson report

"That is humbug," said Col. Hughes.
Where the Wine Went. paragraph which Mr. Guthrie read from the report stung two Conservative members in the House. Mr. Ferguson commented upon the practice of buying expensive wines and foods for consumption on the canal and charging them to the Government. Mr. Guthrie read an affidavit which affirmed that the food and drink in question was bought for the consumption of J. H. Burnham, the Conservative member for West Peterboro; for J. H. Sexsmith, the Conservative member for East Peterboro, and Mayor Bradburn, when th se gentlemen made an inspection trip upon the canal.

The Conservative members jumped to their feet instantly. "I didn't know that we were getting anything on the Government; I didn't, anyway," said Mr. Sexsmith.

DIVER EXAMINES THE SUNKEN LINER EMPRESS

[Canadian Press.] Rimouski ,Que., June 8 .- The first step towards recovering the bodies lying imprisoned in the wrecked Empress of Ireland was taken yesterday afternoon, when a diver descended from the Canadian Government lightouse tender Druid, and for upwards of an hour investigated the accessible parts of the sunken liner. The Empress was found to be lying on her

side, in about 180 feet of water. On board the Druid, besides several government officials, were Captain Walsh, marine superintendent of the C.P.R., and George Weatherspoon wrecking expert, who has been engaged by the railway company to under-take the task of bringing the remainder of the victims of the disaster to the surface, several divers and embalmers. Question Raised as One Funnel Is Seen Instead of Two-Captain White Thinks Other May Have Gone.

[Special to The Advertiser.] Erieau, June 8.—Is the hull of the steamer located fifteen miles southwest of this port by the Wrecking Company, the long lost Bessemer No 2?

This is the question that is being asked today. Since the discovery of he hull, the greatest interest has been aroused, not only in Ericau, but throughout the country. The disappearance of the Bessemer, that went down in 1909 with a total death roll of 32, created the liveliest interest in the discovery of Captain White.

Since the discovered hull has been uoyed, the water has cleared somewhat and a funnel has been seen, fourteen feet under water. The fact that there is only one funnel is the reason that the question has been raised whether the boat is really the Bessemer. big car ferry had two, but Captain White has given his opinion that one of these may have been carried away.

No Other Missing. So far as Ericau people know there no other boat that has gone ashore in this vicinity in recent years that has not been accounted for, the White Company alone having located three wrecks. Therefore, many of the water wise are convinced the discovered hull is that of the Bessemer.

While the White Company has located the hull, the work of raising it will be done by another company. The Whites are simply employed by the Underwriters as "locators Divers Expected. It is expected that divers will come

here today from Detroit to make an investigation into the boat and prove its identity, as well as make an examination as to whether or not it can be advantageously raised. If an unfavorable report on this latter proposition is made, the hull will be destroyed by dynamite to safeguard navigation.

The boat lies in about fifty feet of water and is fifteen miles so of the Erieau harbor.

A Menacing Situation. Washington, June 8 .- Administration chiefs face a menacing situation at Tampico, where two of Huerta's gunboats were to arrive today, to blockade the port and seize a war cargo on the Cuban nerchant marine Antifla. There were indications that the United States would balk any such move. That might result n complications which would threaten to

break up the Niagara conference. Secretary of the Navy Daniels' statenent that "there has been no change in the policy of the Government in reference to its desire that the port of Tampico shall be open to all commerce" aroused widespread discussion. However, whether "all commerce" meant contraband of war, no administration official

would discuss. The Huerta gunboats were reported at Tampico early this morning. It did not seem probable that any actual crisis would be precipitated before the arrival of the Antilla tomorrow or Wednesday, unless the Huerta ships immediately declared a blockade. Rear-Admiral Mayo had transferred his family to the battleship Minnesota outside Tampico harbor, and the Constitutionalists there were preparing to resist any attack on the port.

"A feeling may exist in the minds of some of you that having espoused the cause of the new organization, you must be loyal to your party. I don't think the idea of loyalty to any party should sway you.'

"We have not arrived at that stage where we are divided into opposing factions and it is possible that that time may never come.

He went on to say that the oppon ents of union contended that practical unanimity was necessary before such union as suggested could be successful and that such unanimity did not exist; that when the last vote was taken a very considerable number were opposed to union and that there was no indication of any change in the situa-

Change Indicated. "There is indication of a change," he "We have not held any caucus to find out what the present situation is, but there are evidences of a very decided change. For instance, at the assembly in Edmonton some years ago the committee appointed to consider this question contained quite a large proportion of men opposed to union but at least six of them have changed their attitude and have come over to he majority.

"If we do not proceed along the lines of the present majority recommendation and give our people a chance to vote on the question, we shall be breaking faith with them; we shall not be acting as honorable men. We are not justified in stopping now.

Let Majority Rule.

"I am not behind any man in my love for the Presbyterian Church in Canada, but I have always believed and I still do believe that in this great church of our fathers we come to discussion of questions on which there must be diference of opinion at times. We know that good men may differ, and the only way those differences can be settled is by a vote of the majority.

"Many times when a vote has been aken I have been on the losing side. but I have always gone away with the eeling: 'Well, I will abide by the wishes of the minority.' It would hurt our feelings very greatly if we went away from this gathering with the feeling that the minority has been allowed to

No Ritual Absolute. "The minority may say to that, that this is not a question of majorities or minorities, but of the very constitution of the church itself, and that we have no right to discuss the obliteration of the Presbyterian Church in Canada. My reply is that, to my thinking, there is no organization, no set of forms, no ritual which in the divine order is absolute forever. To my thinking that understanding of every true Presbyterian. The riew of the minority seems to be that God has given to a certain organization grace, and that only in that organization can grace be found. I cannot understand any free man holding that view.

"As a matter of fact the church has changed. The Presbyterian Church of my boyhood days is not the Presbyterian Church of today. We are not adhering to one absolute type. We are free men and we are bound to deal with the condiions which face us now in Canada. And those conditions are not the conditions of generation ago. If the minority is alowed to rule and call halt to our work. for one will feel like going away from his assembly saying: 'Ichabod—the glory is departed.

Cannot Go Back. If we take the position that we uperfor to the Methodist Church, that we are too big to unite with them, that is Pharisaical and there will be an intensifying of the demoninational pride and denominational effort. We cannot simply go back to where we were at the

beginning of these negotiations. Another thing we have to take into consideration is the fact that many people are coming into this country to whom the Presbyterian Church means nothing, but who are human souls for whom Christ died. If we don't Christianize these peo-

ple they are going to swamy us." At this point Rev. Dr. Campbell rose objected to Dr. Clark attempting to give his opinion as to the views of the minority. Dr. Clark, he said, had no right to put into the mouths of other people the arguments he expected them


