I do not know of any principle in the bill which distinguishes between small business and large business as such, and if we get the committee dealing with small business as a class of business, as business affected by the subject matter of clause 14, which I take it, deals with a person accused of not supplying certain articles to the trade, there is no principle in the bill so far that the offence relates to a small or a large business. I think it relates to all business. I think the introduction of that distinction goes beyond the principle of the bill or its contents as it now stands. I am also concerned about the final expression that the amendment be put in against the exploitation of the Canadian consumer. It is true, I suppose that the whole principle of the legislation is to prevent exploitation of the consumers, the public, by unfair trade practices, but because of those two instructions I do not think I can accept the amendment as it now stands.

And debate continuing on the point of order;

Mr. Speaker: I have not yet placed the amendment before the House. If the honourable Member who has the floor wishes to move it he is at liberty to do so in the light of the views I hold about this particular amendment.

Whereupon Mr. Crestohl, seconded by Mr. Caron, moved in amendment to the main motion,—That this bill be not now read a third time, but be referred back to the Committee of the Whole for reconsidering the deletion of clause 14 of this bill.

After debate thereon, the question being put on the said proposed amendment, it was negatived on the following division:
