months in which to obtain complete information. It may be quite true that the money has not been paid, but there is no doubt that the department can furnish the information for which I asked.

Mr. DURANLEAU: My information is that these payments are never completed before March 15. During January and February we were still receiving applications from these fishing companies, so we must wait until the claims are all in before we can adjust and pay them, since we have only a certain amount appropriated for the payment of these bounties.

Mr. NEILL: Has the minister considered giving British Columbia and the Pacific coast its share of that fund?

Mr. DURANLEAU: The money will be divided according to the statute.
