SARNIA OLEFINS AND AROMATIC PRODUCTS PROJECT
—PUBLICATION OF LETTER FROM PREMIER
BOURASSA TO PRIME MINISTER

Hon. Martial Asselin (Charlevoix): Mr. Speaker, I should like to put a question to the right hon. Prime Minister.

It seems that the Quebec premier wrote him a letter concerning the development of the oil industry and more

specifically the Sarnia Olefines and Aromatic Products project. I should like to know when he will reply to the letter of the Quebec premier, and whether or not he intends to publish the reply in the interest of hon. members.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I always marvel at how hon. members usually have a copy of the correspondence that is sent to me even before I receive it. I shall look at my mail and see whether it has arrived; if such a letter exists, I hope to read it soon. If I do not have it, then perhaps the hon. member can send me a copy of it.

ESTABLISHMENT OF PETROCHEMICAL CENTRE IN SARNIA—STATEMENT OF QUEBEC MINISTER OF INDUSTRY AND COMMERCE—POSITION OF GOVERNMENT

Hon. Martial Asselin (Charlevoix): Mr. Speaker, the Prime Minister complains about a lack of communication with the Quebec government. Perhaps the relations between the Quebec government and the opposition are friendlier than with this government.

In any event, Mr. Speaker, I should like to put a supplementary question.

The Quebec Minister of Industry and Commerce has expressed serious apprehensions regarding the establishment, at Sarnia, of a world petrochemical centre. Could the Prime Minister say what is the attitude of his government concerning this artificial boundary, the Borden line, which limits Quebec to its own domestic market for the sale of its petrochemical products?

Mr. Speaker: I feel that this question is of a general nature and that it calls for a statement on motions. The hon. member might perhaps agree with me on this point.

Mr. Asselin: Mr. Speaker, I should like to put a supplementary question.

Does the Prime Minister intend to make in the near future in the House a statement on such an important matter, in order that we may know what is the government's position on that problem raised yesterday by the Quebec Minister of Industry and Commerce?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I will surely examine the letter, if there is one. However, in answer to the hon. member, I simply want to make him understand that the oil policy to which he referred has enabled Quebec to pay less for its fuel than the western provinces which have to buy their oil in western Canada. Well, if this is not a beneficial policy for Quebec—

Mr. Speaker: Order. It seems to me that such a question and the Prime Minister's answer are rather argumentative and I also feel that we should try to proceed a little more quickly.
