That this House request the Prime Minister to place for discussion on the agenda of the Constitutional First Ministers' meeting in March, 1983, the amending formula under Section 38 of the Constitution Act, 1981, and that every effort be made to change the amending formula in this Section to require two-thirds of the Provinces having 80 per cent of the population instead of 50 per cent of the population of the Provinces, and that the opting out feature be deleted.

THE PHILIPPINES—OPPOSITION TO REQUEST FOR EXTRADITION TREATY

### SEARCH AND RESCUE

CROSS REPORT—LACK OF CONTINGENCY PLAN

Hon. James A. McGrath (St. John's East): Madam Speaker, my question is for the Minister of National Defence who yesterday tabled in the House an interdepartmental report on search and rescue in Canada, called the Cross Report. Among other things it describes search and rescue as confused and poorly managed, and in some very strongly worded recommendations it speaks to the fact that Canada lacks a contingency plan to deal with a major marine or air disaster.

Madam Speaker, my question to the Minister of National Defence, who I presume is the lead Minister in this area, is this. The *Ocean Ranger* went down last February with the loss of 84 lives. Off Nova Scotia we will have four rigs with anywhere up to 1,500 men, and off Newfoundland we will have three rigs with anywhere up to 900 men. Given all that, why do we not have in place at the present time a contingency plan to deal with an emergency at sea or in the air?

Hon. J. Gilles Lamontagne (Minister of National Defence): Madam Speaker, first of all I would like to correct the Hon. Member when he said that the search and rescue operation was confused and that the people manning it were not competent or were badly trained. I think the Cross Report, if you have read it, says completely the contrary. The people are very devoted, motivated, well trained and competent people who are risking their lives on many occasions for search and rescue operations. I think that is what it said.

Some Hon. Members: Hear, hear!

Mr. Lamontagne: As far as the East Coast is concerned, I know the concerns of the Hon. Member because he has questioned me in the House quite a few times on this subject, and I have written also to him quite a few times concerning search and rescue on the East Coast. He asked at one point why we would not put fixed wing aircraft in Newfoundland. This I will answer in a moment.

On the second question about our SAR resources on the East Coast, I think in the Cross Report it is well stated on many occasions that the facilities and the capabilities of search and rescue on the East Coast are well located. The Report does not suggest relocating any of our facilities at the present time.
