SKIDWAY AT CHERRY HILL, N.S.

Question No. 4,515—Mr. Crouse:

1. Has the skidway at Cherry Hill, Lunenburg County, Nova Scotia, threatened with removal by the Department of Fisheries and Oceans in September, 1982, been removed and (a) if not, has the skidway and the land on which it was constructed been purchased by the Government (b) if so (i) who owned the land on which the skidway was constructed (ii) what amount was paid by the Government for the land and skidway (iii) what was the total amount paid initially towards the skidway by the Government?

2. What is the name of the government official who approved the construction of the skidway on land to which the Government did not have a clear title?

Hon. Pierre De Bané (Minister of Fisheries and Oceans): 1. The skidway at Cherry Hill has not been removed, nor was it ever "threatened" with removal by the Department of Fisheries and Oceans. The owner of the land on which part of the skidway was constructed had demanded its removal.

(a) The land on which the skidway was constructed has been purchased by the Government.

(b) (i) The land on which the skidway was constructed was owned by Mr. W. K. Allen. (ii) \$25,000. (iii) Originally, \$20,000 in material support was provided to the project sponsor by Small Craft Harbours Branch, under the Canada Works Program. The labour content of \$7,000 was provided by the Job Creation Branch of the Department of Employment and Immigration.

2. In 1976, CEIC approved the project as being acceptable under the terms and conditions of the Canada Works Program. At that time, the project sponsor, Mr. S. Conrad, indicated that the skidway could be constructed at a site on which he operated a fish store. Small Craft Harbours agreed to support the material portion of this project, which was constructed by local fishermen for their use. It is within the mandate of Small Craft Harbours to support projects sponsored by the Canada Works Program and the Canada Community Development Program, even if they are not at scheduled harbours.
