NEED TO MAINTAIN JOB-CREATION PROGRAMS

Mr. Jean-Claude Malépart (Montreal—Sainte-Marie): Mr. Speaker, the newspaper La Presse has just published five articles which clearly illustrate the catastrophic situation of poor people in Greater Montreal and Quebec generally. These articles indicate that more than half a million people in the Montreal metropolitan area live under the threshold of poverty and have to line up to get a bowl of soup. The articles also point out an 11-year life expectancy gap between the residents of Saint-Henri and those of Mont-Royal.

We are told as well about the appaling living conditions of younger people who, forced to make do with meagre social assistance benefits, must also queue up in bread lines.

In my opinion, Mr. Speaker, both the Minister of Employment and Immigration (Mr. Bouchard) and the Minister of State (Youth) (Mr. Charest) ought to read these articles if only to appreciate the fact that, contrary to what they claim, instead of slashing into job creation programs—such as community development or Challenge 87 projects—and

shifting them onto the private sector, they should continue to fund them in support of charitable organizations which help people get out of their misery.
