The Canadian government cross-border shops for its test fuel to get MMT-free gasoline. If it used gasoline containing MMT, Canadian automobiles would not pass the emission tests.

MMT, in addition to being a suspected health risk which has been banned in the United States since 1978 for its damaging effects on the pollution control devices of cars, boosted hydrocarbon emissions by up to 27 per cent according to the government's own testing in 1985.

Instead of waiting until 1996 to cut hydrocarbons in the lab by 29 per cent, I call on the minister now to ban MMT and cut those emissions by as much as 27 per cent.

It is time the government came clean on its emission testing standards and revealed just how bad MMT emissions really are. Faking emission testing will not help the environment; real cuts will.

WORK PLACE SAFETY

It has to do with the presence of PCBs in paint on rolling stock that carmen are being called to work on.

On numerous occasions carmen have expressed their concern about this matter. There is growing anxiety and even anger among them that Labour Canada does not appear to want to take an interest in this issue. Labour Canada does not exist to defend the interests of the CPR or the CNR. It exists to enforce existing rules and to make sure that there is such a thing as work place safety and health.

I call on the minister to take an interest in this issue by making sure that something is done about the information that has come to light about PCBs in paint on certain cars, and most recently with respect to truck sides that carmen have to work on. I hope the minister will soon do something about this and have Labour Canada live up to its mandate.
