The destruction of my ministerial papers covering a crucial period in Canadian history was an act of bureaucratic vandalism, which has caused me great personal anguish and anxiety. I pressed for the ongoing investigation and implored the department to produce whatever material it had on file. No relevant material has ever been located.

The political discussion and the policy process reflected in the destroyed material have a value to Canadians, including myself, far beyond any cash payment made to me. The loss is devastating and can never be justified. Attempts by bureaucrats, the media and the opposition to pretend these papers still exist are irresponsible in the extreme.
