A GREAT PRINCIPLE AT STAKE.

Whether or not the Metropolitan Railway is running rights over the Toronto company's system is a matter of indifference to most of the members of the Legislature.

It is equally a matter of indifference to a majority of the inhabitants of this province.

But the sanctity of municipal rights appeals to every resident of the province, and it should appear in a very strong way to every member of the Legislature.

What the Metropolitan Railway is really seeking is that the Legislature should abdicate its right to control the city of Toronto and the adjoining municipalities.

Every session we find interested parties invoking the Legislature to override the authority of different municipalities in the conduct of their own business.

Two parties are at issue, before the Legislature at the present time. One of them asks the Legislature to usurp the authority of the City of Toronto over one of its principal highways.

The other invites the Legislature to use a club on the Township and County of York, and compel them to become responsible for a bridge constructed as a private enterprise by a real estate company.

The real question before the Legislature today is not the Metropolitan Railway or the Ontario Bridge, but the mastery of the City of Toronto and the adjoining municipalities. We trust the members of the Legislature will not allow themselves to be hoodwinked by the specious arguments of special pleaders.

When the Metropolitan people renew their application for running rights over the Toronto Railway, let them be made to show cause why their application should not be referred to the City of Toronto, in whom the jurisdiction lies. The rights of the municipalities should be held as inviolate as provincial rights.

At any rate, no interference by the Legislature should be tolerated unless under extraordinary circumstances. In the two cases now before the Legislature there is no excuse whatever for the applications.

It will be time enough for the Metropolitan Railway to invoke the Legislature to usurp the jurisdiction of the City of Toronto when it establishes the fact that the City of Toronto has failed to do some duty upon which it has excused its power in some particular.

No such excuse will be given by the Legislature to the Metropolitan Railway.

The city has never refused to make an agreement with the Metropolitan for running rights over its streets. As a result of the city's failure to do so, the Metropolitan is now applying to the Legislature to give it the right to run its tracks over the city's streets.

The same line of argument applies to the Ontario Bridge. Why should the Legislature interfere in a matter which is entirely within the jurisdiction of the municipality? This bridge is purely a local question. The City of Toronto and the Township of York are surely competent to look after their own streets and highways and bridges. Whether one of the Roadside railways is or is not spanned by a bridge may be a matter of some importance to those living in the immediate vicinity, but how can the matter affect the province at large?

The farmers of York County know their own wants better than the members of the Legislature, and as long as they are satisfied with their roads and bridges there is no call for interference by the Legislature in the matter.

If there were arguments to be advanced on behalf of the Ontario Bridge, it would be possible, and indeed probable, for certain members to be misled, and to vote against the charter in good faith, but under the existing circumstances no such excuse can be made for an act of this kind.
