SENATE AND RESPONSIBLE GOVERNMENT

Conduct of Liberals in Red Chamber Jeopardizing People's Liberty

Laurier Trying To Force His Way Back

Sir Wilfrid and His Melodramatic Counsellors Now Face to Face with Themselves—Personal Ambition the Reason for their Action.

(Quebec Chronicle.) We are never so prone to praise the men who fought for responsible government in our British North American provinces and prepared the way for its perpetuation in the confederacy of our present-day Canadian commonwealth. To every Canadian it stands as the veritable Magna Charta of our political freedom. It has provided a way for the voice of the people to make of no avail the curvettings of the political hood-winkers and self-seekers. It is an assurance of fair play in our party ascendancy. And if, as the Toronto Globe and the Halifax Chronicle would lead us to infer, Sir Wilfrid Laurier has been taking part in the bringing about of a "combustion" of his partisan friends in the Senate, to rescue himself from the effects of the "mistake of his life," then is there a decided imperilling, by such conduct, of one, if not more, of the fundamental principles of responsible government.

Indeed, it is easy to perceive what has been running in the Premier's mind for some time back, in regard to how he was going to force an appeal to the country, cost what it might, and the country's exposure to the means of giving him another throw of the dice. Even before the Borden government had been run into the ground down to business, he had started his game of forcing his way back to the premiership. In face of his repeated pre-election declarations that he would never demand himself by accepting the leadership of the opposition, he, without the tremor of a nerve over the inconsistency, accepted the position at the salary formerly fixed by himself. Thereafter, he insured his command in the Senate and villages of Ontario, in favor of re-inaugurating "Reciprocity" as an international question, in spite of the deathblow the proposal had received at the hands of the people in terms of responsible government.

Then it was that the suspicion arose in the minds of many whether Sir Wilfrid had a proper and abiding respect for the principles of responsible government. And now that suspicion has deepened into a certainty through the encouragement he has lately been giving his followers in the House of Commons—very much against their inclinations in some instances—to applaud the melodrama lately staged by Messrs. Emerson and Pugsley, which has happily effected as heedless folly generally does, in making fools of the men inaugurating it.

The Toronto Globe and the Halifax Chronicle assure us that there are Senators, enough and to spare, who dare not think of making any of the pleadings of Sir Wilfrid to have them reject the Navy Aid Bill. Does this mean that the ex-Premier is to be taken as one of the party, who is not of it, nor can be, on account of some birth-mark he is always fondling in some secret place of his get-up? Yesterday we said that Sir Wilfrid is now face to face with himself; and just as certainly has Sir Wilfrid Laurier come face to face with himself, as one who would willingly enough set aside the terms of responsible government in his efforts to have another throw of the dice. The resignation that presents itself forcibly to every constituency in the land is: Are the members of the Senate, any or all of them, prepared to help out Sir Wilfrid in his great gaming venture? Are they prepared to set aside even for the moment, the principles of responsible government—setting up Sir Wilfrid's whim of trying to get back to power, in direct opposition to the voice of the people as expressed by the House of Commons?

"Let us have another general election," is the demand of Sir Wilfrid and his birds of prey. In fact he would have a general election every week-end, or rather till he should by any chance be placed in power again. But his melodramatic counsellors hardly be thinking, in their hysteria, of what another general election, so soon after the last, would mean for them. The majority of the Senate cannot but have their suspicions, with the rest of us, as to what would happen were the Senate to break in upon the principles of responsible government in order that an ex-Premier should be placed in authority over a constitutionally selected prime minister of Canada. Mr. Borden is at present prime minister. Sir Wilfrid Laurier happens to be ex-premier.

BIBSON WILL TRY AGAIN TO PROVE HIS INNOCENCE OF GREENWOOD LAKE MURDER

The second trial of Burton W. Gibson, the New York lawyer who is accused of murdering Mrs. Rosa Szabo, his client, on Greenwood Lake, N. J., by strangulation after upsetting the boat in which they were rowing, was set for Friday, May 23. This promise to be even more exciting than the first trial, in which the jury failed to reach an agreement. Gibson, who was the attorney for the murdered woman and who had drawn her will, in which he was made the sole beneficiary of the \$10,000 estate, shortly before her death, says that he has no money to continue his fight to prove his innocence.

Is he afraid that the permanent naval policy of the Conservatives will make unpalatable his number of his Imperialism, which is so much of a back number already? If the Senate would have the Laurier type of Canadianism or Imperialism pass beyond observation, its members had better avoid identifying it as their own while doing their duty towards the Motherland.

SYNOPSIS OF CANADIAN NORTH-WEST MINING REGULATIONS.

COAL.—Coal mining rights may be leased for twenty years, renewable at an annual rental of \$1 per acre, more than 2,000 acres can be leased to one applicant. Royalty, five cents per ton. In unreserved territory the tract must be staked out by the applicant in person, and personal application to the Agent or sub-Agent of Dominion Lands for the district, must in all cases be made and the rental for the first year must be paid to the agent within thirty days after staking.

PLACER MINING CLAIMS are 500 feet long and from 100 to 2,000 feet wide. Entry fee, \$5. Rent, \$2 per acre. At least \$100 must be expended on the claim before the expiration of the first year. When \$100 has been expended on a claim, it may be purchased for the full value of the claim.

DREDGING.—Two leases of five miles each of a river or stream may be made for a term of 30 years. Rental, 10¢ a mile per annum. Royalty, 10¢ per cent after the output exceeds 100,000 bushels.
