

RAILWAYS.**NORTHERN RAILWAY COMPANY OF CANADA. HAMILTON AND NORTH-WESTERN RAILWAY COMPANY.**

THE NORTHERN RAILWAY main line, Toronto to Collingwood (94.96 miles), was opened in 1854; the North Grey extension (20.50 miles) from Collingwood to Meaford, and the Muskoka Branch (49.71 miles) from Barrie to Gravenhurst, were amalgamated with the Northern Railway in 1875. The North Simcoe Branch, Allandale to Penetanguishene (33.34 miles), was opened in 1879. The HON. FRANK SMITH, President Northern Railway.

THE HAMILTON AND NORTH-WESTERN RAILWAY, from Port Dover to junction with Northern Railway at Allandale (134.07 miles), from Beeton to Collingwood (39.83 miles), was completed in 1878. JOHN STUART, President; MAITLAND YOUNG, Secretary. Address, Hamilton.

In 1879 an agreement was entered into by the two Companies whereby both lines are operated by a joint Executive Committee of Directors of the two Companies. The total distance thus operated is 372.41 miles.
