by federal authority; basic function of government to be found in federal legislature; tabling of report on dominion-provincial relations commission; suggestion in report that federal government take over financing and servicing of provincial debts; defence of Canada regulations, 25; effect of repeal of section 98 of criminal code; practice of referring matters of importance to committees of the house; vesting the executive with power to control subversive elements in the country; war effort of the present administration; situation in Canada prior to September, 1939, 26; establishment of government munitions plant in Quebec under Bennett government; change in conditions from 1935 on with respect to national defence; efforts of Right Hon.
