## FOREIGN AID—INQUIRY AS TO SHIFT IN POLICY AND ASSISTANCE TO NORTH VIET NAM

**Mr. W. B. Nesbitt (Oxford):** I have a question for the Secretary of State for External Affairs. Was Mr. Gérin-Lajoie stating government policy when he announced last weekend that—

**Mr. Speaker:** Order, please. The hon. member is asking whether an official of the government is stating government policy when he makes a statement. I have to tell the hon. member that a question asked in those terms is not in order. It has long been a recognized rule of the House that it is possible for an hon. member to ask the Prime Minister whether a statement made by a minister represents government policy, but I would suggest that if hon. members ask questions on whether statements made by public servants represent government policy we may get ourselves into difficulty. From day to day the whole question period might be used for that purpose. Would the hon. member rephrase the question?

**Mr. Nesbitt:** I realize Your Honour is quite right but I thought a question about a statement by such a senior official might be accepted. Is it government policy to have a large shift in emphasis in our foreign aid programs and, in particular, is it government policy now to advance foreign aid to North Viet Nam?

**Hon. Mitchell Sharp (Secretary of State for External Affairs):** No, Mr. Speaker, I am not aware of any proposals to grant aid to North Viet Nam.

**Mr. Heath Macquarrie (Hillsborough):** I wish to direct my question to the Acting Prime Minister.
