FEDERAL-PROVINCIAL AFFAIRS

DATE OF CONFERENCE WITH WESTERN PROVINCES—AGENDA

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, may I ask the Prime Minister whether the date has been set for the proposed conference between the federal government and British Columbia, Alberta, Saskatchewan and Manitoba and whether a statement will be made to the House as to the priorities that will be discussed in reference to the economic opportunities as mentioned in the Speech from the Throne at that western conference?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, as to the date, none has been set. The announcement, of course, was only made last week in the Speech from the Throne and exchanges are now taking place between the provinces and myself to try to find a date and place for that conference as well as a proper agenda. On the second part of the question, the hon. member will see that in the Speech from the Throne itself several examples of things that we think should be discussed are given there.

Mr. Woolliams: Mr. Speaker, may I ask one supplementary following what the Prime Minister said. Is the Prime Minister considering discussing with the western provinces in particular that phase of the change in taxation under which the estate tax was abolished and replaced by a capital gains tax so that those provinces will share, as they did in the previous tax provisions, to the extent of 75 per cent of the national revenue?

Mr. Trudeau: Mr. Speaker, we will refuse to discuss no subject which is placed on the agenda by the provinces themselves. I would hope that at this particular conference we would especially consider items which have to do particularly with the economic development of the western provinces and not necessarily with subjects that are common to all provinces, or a multitude of provinces, and which can be discussed at other forums such as the finance ministers' meetings.
