LOSSES ON SPECIFIED SUBDIVISIONS

Question No. 1,876—Mr. Mazankowski:

1. For each year 1970 to 1974 what were the calculated losses for providing rail service, excluding passenger, for (a) CNR Subdivision Bonnyville, Edmonton to Grand Centre (b) CNR Subdivision Coronado, Edmonton, St. Paul, Heinsburg (c) CPR Subdivision Willingdon, from Musidora to Lloydminster?

2. For each Subdivision what amount was (a) claimed by the railways under the provisions of the Railway Act (b) paid in lieu of claims by the government?

Hon. Jean Marchand (Minister of Transport): The Canadian Transport Commission advises as follows: 1. (a, b) CNR, to date has not filed subsidy claims for these lines. (c) CP's Willingdon subdivision extends from Lloydminster at Mile 0.0 through Musidora at Mile 80.8 to South Edmonton at Mile 174.5. CP's claim for this line encompasses the uneconomic portion of the line from Mile 1.4 to Mile 162.8. Latest claimed losses for Mile 1.4 to Mile 162.8 were: 1970—\$783,426; 1971—\$1,031,215; 1972—\$923,274; 1973—\$904,921 and 1974—\$1,125,661 (preliminary estimate).

2. (a) CNR, to date has not filed subsidy claims for these lines and no payments have been made in respect of these lines. (b) CPL submitted the following claims for losses under Section 258 of the Railway Act for the years 1970 to 1974 for the Willingdon subdivision from Mile 1.4 to Mile 162.8 and were paid the following:

1. What is the total revenue derived on the rail line from Musidora to Lloydminster, Alberta?

2. What is the total revenue under statutory rates for the line?

3. What is the total mileage from Musidora to Lloydminster?

Hon. Jean Marchand (Minister of Transport): The Canadian Transport Commission advises as follows: 1. The total revenue derived on any rail line consists of revenue from carload traffic, leases and other agreements. Total revenue from carload traffic on the rail line from Musidora, Mile 80.8, to Mile 1.4 (excluding Lloydminster) was: 1970, \$419,316; 1971, \$538,607; 1972, \$546,894; 1973, \$46,342. Total revenue for 1974 is not available at this tir ... Revenue from leases and other agreements was in th \$3,000 to \$4,000 range per year.

2. Total revenue under statutory rates from Musidora, Mile 80.8 to Mile 1.4 (excluding Lloydminster) was: 1970, \$387,081; 1971, \$524,790; 1972, \$526,216; 1973, \$440,554. Total revenue under statutory rates for 1974 is not available at this time.

3. Total mileage from Musidora to Lloydminster is 80.8 miles.
