Mr. Collenette: Madam Speaker, I ask that the remaining questions be allowed to stand.

Mr. Cossitt: Madam Speaker, I rise on a point of order to correct a statement I made in the House yesterday on a point of order with reference to one specific question, namely, No. 30, which I said had not been answered for a little over two years. The reason I rise to make this correction is that I have checked the matter out thoroughly and I have found that the answer has not been forthcoming for five years and five days as of today. I think that is probably a parliamentary record for stalling by this government.

If Your Honour will permit me to do so, I propose to read the question into the record. It is very short but I would like to read it into the record to show how simple it is and then ask the parliamentary secretary why, after five years and five days, this question has not been answered. It reads as follows:

- 1. Since January 1, 1973, what are the names and job designations of all persons employed by, connected with, or in any way associated with, the Canadian Transport Commission who were issued passes by Air Canada?
- 2. Did the wives or personal associates of any such individuals hold permanent or temporary passes of any kind on Air Canada during the same period and, if so, what are their names?

I do not see why it should take over five years to compile a list as simple and straightforward as that.

#### Mr. Broadbent: Why didn't your government answer it?

Mr. Cossitt: My friend on the far left from points south off the coast of Florida, etc., is asking in a heckling way why our government did not answer it. Because of inquiries I made at the time I know an attempt was being made to put the information together, but before the present government went out of office, it spent four years doing absolutely nothing. There is no reason why the preliminary work in compiling the answer done by the previous administration could not have been finished by this government long ago.

I suggest it is a record in any Parliament when a government neglects to answer a question for five years and five days. I think it is disgraceful. It is indicative of an arrogant adminis-
