I simply indicate to the hon. member that while we would have liked to have seen stronger growth, there are some signals in the area of housing, in the area of corporate profits, in the area of job creation that would indicate that the modest to moderate recovery that we have projected and predicted is still there.

Mr. Steven W. Langdon (Essex—Windsor): Madam Speaker, the minister is living in a dream world. What exists out there across this country among farmers, workers, the unemployed, the poor, is a very tough situation. The minister seems to be in a dream world instead.

I ask the minister why he is not prepared to stand up and recognize that we have had two successive months of decline and this government has to take decisive action to change its policies and get Canadians back to work.

Hon. Don Mazankowski (Deputy Prime Minister and Minister of Finance): Madam Speaker, I am not in a dream world. We have had two consecutive quarters of growth. That is the fact. The hon. member says do something. The hon. member is suggesting to spend, borrow more money, spend it, kick-start the economy.

As I indicated earlier, I am engaged in my pre-budget consultations. I can tell you, Madam Speaker, there is no consensus for that course of action. The course of action that is recommended is the one that we are on, getting the fundamentals right, getting interest rates down, getting inflation down, getting the inflationary pressures down, bringing our fiscal house into some order. Those are the recommendations I am receiving from Canadians and I believe very sincerely that that is the right approach for the future of a strong, robust Canadian economy.

Mr. Steven W. Langdon (Essex—Windsor): Madam Speaker, what I hear from Canadians, business, labour, everybody, is first that we have to get rid of the GST and, second, we have to get a lower dollar in this country. That will put us back on the road to recovery.
