CANADA COUNCIL GRANTS

Question No. 1,830-Mr. Smith:

In the 1964-65 budget of the Canada Council, in the category, theatre, ballet and opera, what organizations are to receive grants and in what amounts?

Hon. Maurice Lamontagne (Secretary of State): Because of section 13 of the Canada Council Act, the council is not an agent of Her Majesty; consequently, the government does not have records showing the statistics requested in this question, and the government has no power to direct the council to supply this information. The legal relationship was explained by the Right Hon. J. G. Diefenbaker on November 27, 1957 (Hansard, pp. 1558-9) and on June 18, 1958 (Hansard, p. 1389).

* FEDERAL FACILITIES TO FLY FLAG

Question No. 1,889-Mr. Coates:

1. What is the estimated cost to the federal treasury that will result if a new flag design is approved by parliament?

2. How many federal buildings are there within Canada either owned or rented by the federal government which presently have the necessary facilities to fly the Canadian flag?

3. How many buildings either owned or rented by the government outside Canada have the necessary facilities to fly the Canadian flag?

4. How many Canadian red ensigns of various sizes are presently the property of the Canadian government?

Mr. J. B. Stewart (Parliamentary Secretary to Secretary of State): 1. Many of the flags of the Canadian red ensign design withdrawn from service on February 15, 1965 were not new; accordingly, to state their financial value precisely would be impossible. The unit costs of new flags of the two designs will be approximately the same.

*REPORTS ON CONDUCT OF HAL BANKS Question No. 2,042—Mr. Francis:

1. Did the Department of Justice, in 1958, through the R.C.M.P., conduct an investigation to determine [Mr. Lamontagne.] if Hal Banks had been employing intimidation and violence in the furtherance of union activities?

8. When was action initiated by the government to prosecute Hal Banks?

- Mr. D. S. Macdonald (Parliamentary Secretary to Minister of Justice): 1. Yes. In November, 1958, the Minister of Justice instructed the R.C.M.P. to conduct an exploratory investigation into the activities of Hal Banks as information had been received which suggested that Banks was using his position and influence to intimidate other unions and when any degree of opposition was met, he was not hesitating to use force or threats of force.
- 2. The R.C.M.P. advise that on February 23, 1959, they forwarded a preliminary report to the Minister of Justice, under secret cover, outlining the findings of their investigation into the activities of Hal Banks, which included an account of the conspiracy to beat Captain Walsh.
