"If the Canadian government had the right to seize the Hartford at Port Colborne," C. E. With the right to seize goes the right to use force, and if the Hariford should disobev the orders of the Canadian revenue cutter in Canadian waters the cutter might bring the Hartford to time by sending a shot through her. # AND HELD WITHOUT BAIL

Court Will Decide Whether Emma and the Other Nine Anarchists Shall be Released on Bond or Incarcerated Until The Preliminary Hearing.

Chicago, September 11.-Magistrate Prindivide to-day decided that Emma Goldman, the anarchist lecturer under arrest here should be held without bail, pending the decision of similar cases in the superior court.

The action of Justice Prindiville in olding her without bail extends only to Friday of this week. At that time the question will be reconsidered and the magistrate will decide whether she shall be held without bail or released under bonds until the preliminary hearing of the charge against her, which is set for September 19.

Miss Goldman appeared for a hearing before the magistrate during the forenoon. She had not secured counsel, but in a determined voice declared that she was ready to act, as her own attorney. The assistant city prosecutor, however, obtained a continuance of the hearing till Sept. 19, the fate set for the hearing of the other anarchists in custody here. Owens, the pro-secutor, states that the result of an investigation at Buffalo was being

awaited. The court postponed its decision in the matter of bail, which Miss Gold-man demanded the privilege of furnishing, until later in the day. While waiting, Judge Chettain in the Su-perior court held the other anarchists until Friday, when he said he would hear arguments in the applications for writs of habeas corpus. As the charge against Miss Goldman, "conspiracy to murder President McKinley," is the one lodged against the local anarchists, who are named as co-conspira-tors with Miss Goldman, Magistrate Principally thought it wise to await the decision of the higher court.

LAWYER'S PLEA. He said it would not be necessary for counsel to apply for a writ for Miss Goldman, as he would deal ex-actly with Miss Goldman, as Judge Chetlain did with the other prisoners. Miss Goldman was represented by Lawyers Brown, Geeting and Saltiel. They were busy in the habeas corpus case during the forenoon, but inter-viewed their client in time to appear for her in the hearing on the matter

Lawyer Geeting, in pleading for the prisoner, said: "This matter must be disposed of according to well-known rules of law. When a party is brought into court charged with any criminal offense that party has a right to an immediate hearing. Section 7, Article 2 of the constitution of Illinois declares that all persons shall be bailable by suffiall persons shall be ballable by surficient sureties, except for capital offense where the proof is evident and the presumption great. When a person is brought into court on a charge, even though it be a capital case, it would be bailable unless there was some evidence to the court that the proof was evident and the preseump-tion great. Otherwise, the constitu-tion would not say that all offenses

In this case the affidavit filed does not conform with the law because the law requires an oral examination, the affidavit to be based on that oral examination. It should be upon persons knowledge as to the facts. That is a provision of the constitution which we are all sworn to support, and the ignoring of which is a denial of the right of government, to guarantee the

rights of the citizen. JUDGE'S DECISION. Coursel then contended that none of

these constitutional requirements had been complied with in the case of Miss In deciding the case, the court said

"While this morning I was inclined to believe that the defendant might be entitled to bail, considering the condition that the president is now in, at that time of course, I did not know that there was any proceeding pend-ing, or that it was going to be taken to a higher court. Of course, this present defendant is in charge, just the same as all the rest of them, She in charged jointly with them in con-spiracy, the case being taken to a su-perior court. I did not feel as if I should now take any action, which night be contrary to the decision to be arrived at by the upper court, or that would in any way influence the court in the matter there pending, That being the case, feeling as I do, and with the understanding that I had with counsel this morning that if Judge Chetlain admitted the other defendants to bail, or if anything was done I would do the same, I still say that I will remand this defendant and if Judge Chetlain, at 11 o'clock Friday morning shall admit these prisoners to bail I will immediately send for Miss Goldman, or, at whatever time I hear of it, and will do the same; that is, I will admit her to bail , the same as the

EMMA GOLDMAN'S REPLY. Chicago, Sept. 11.—When shown a dispatch from New York, stating that Czolgosz had admitted there was a plot to assassinate the President and implicating her, Miss Goldman said:

# **EMBRACED**

Kaiser and Czar Gave Each Other Warm Welcome.

Nicholas Took Luncheon on Board the Hohenzollern - Lamsdorff and

Von Buelow Present. Hela, Prussia, Sept. 11 .- The meeting between Emperor Nicholas and Emperor William was favored with perfect weather. The Hohenzollern, flying the German and Russian imperial standards at the main, welcomed the Standart with an imperial salute, which the Standart returned, both brews dressing ship, while the bands played the Russian and German national anthems.

Count Plateau, the kaiser's aide, went on board the Standart to escort the tzar, who went on board the Hohenzollern. The kalser received his imperial visitor at the gangway, where the two monarchs

each other. They then inspected the guard of honor together, after which they retired to the quarter deck, where they remained in animated conversation until luncheon, when the czar sat on the right of the kaiser and Grand Duke Alexis on the left. The lunch-eon party included Count Lamsdorff, the Russian foreign minister, Count von Buelow, the German imperiat chancellor, Count von Eulenburg, Baron Fredericks, Count von Schlief-fen, Admiral von Hoffman and Ad-

miral von Tirpitz. Just as the meal ended Hela was sighted. The German squadron was drawn up in double line, the vessels being decorated with bunting and the crews manning their sides. The Hohenzollern, with their imperial greats on the importal bridge, steemed Hohenzollern, with their imperial guests on the imperial bridge, steamed slowly between the lines, followed by the Standart and her escort. The two yachts anchored at the heads of the respective lines, after which the admirals and principal officers of the squadron went on board the Hohenzollern and were presented to the czar.
