

Synopsistof Coal Mines Regulations.

COAL mining rights of the Dominion, in Manitoba, Saskatohewan and Alberta, the Yukon Territory, the North-West Territories, and in a portion of the province of British Columbia, may be leased for a term of twenty-one years, renewal for a further term of 21 years a nanual reutal of \$\\$1\$ an aere. Not more than 2560 aeres will be leased to one applicant.

Application for a lease must be made by the applicant in person to the Agent or 'Sub-Agent o' the district in which the rights applied for are situated.

In surveyed territory the land must be described by sections, or legal sub-divisions of sections, and in unsurveyed territory, the tract applied for shall be staked out by the applicant himself.

Each application must be accompanied by a fee of \$5 which will

Each application must be accompanied by a fee of \$5 which will be refunded if the rights applied for are not avaitable, but not otherwise. A royalty shall be paid on the merchantable output of the mine at the rate of five cents per ton.

The person operating the mine shall furnish the Agent with sworn subura accounting for the full quantity of merchantable coal munon and pay the soyafity thereon. If the coal mining rights are not being operated, such returns should be furnished at least once a year. The least will identify the coal unining rights only, rescinded by Chap. 37 of 4.5 George V. assented to 12th June, 1514.
