APPENDIX I

INTERIM AGREEMENT ON INTERNATIONAL CIVIL AVIATION

The undersigned, on behalf of their respective governments, agree to the following:

ARTICLE I

THE PROVISIONAL ORGANIZATION

Provisional international organization.

The signatory States hereby establish a provisional international nization of a technical crul organization of a technical and advisory nature of sovereign States for the purpose of collaboration in the field of international civil aviation. Structure of Provisional Organization.

The Organization shall consist of an Interim Assembly and an rim Council, and it shall be seen to be a seen t Interim Council, and it shall have its seat in Canada.

Duration of interim period.

Legal capacity.

ARTICLE II

THE INTERIM ASSEMBLY
