Supply-Labour

The Chairman: I am sure the hon. member for Hull would not wish to leave that remark on the record.

(Translation):

The Chairman: The hon. member for Hull (Mr. Caron) has just accused the chairman of being partial. I am sure he made that remark in the heat of the discussion. Therefore, I shall give him the opportunity of changing the words he used.

Mr. Caron: Mr. Chairman, we have noticed that you often look on this side and seldom on the other side when interruptions are made. That is why I made that remark.

The Chairman: I insist that the hon. member unconditionally withdraw the words he just used.

Mr. Caron: The chairman is more strict for the members on this side of the house than he was for the hon. member for Roberval (Mr. Tremblay).

The Chairman: I ask the hon. member for Hull to comply with the instruction that I am giving him with all due consideration. I am sure he agrees with me that no one should make such remarks to the chairman of this committee. I hope that he will take the opportunity I am offering him to withdraw unconditionally the remarks he has just made.

[Editor's note: The hon. member for Hull having given no reply.]

The Chairman: Do I understand that the hon. member refuses to withdraw his remarks?

Mr. Caron: Mr. Chairman, it is most difficult for me to withdraw remarks which are known to be true.

The Chairman: Then, I must report to the Speaker.

Mr. Caron: Some remarks have been made from the other side of the house which should also be withdrawn.

The Chairman: I expect hon. members will refrain from further remarks until the arrival of Mr. Speaker.

Mr. Flynn: Dirty fellow.

Mr. Caron: The minister has just made an ungracious remark about me and I would ask him to withdraw.

Mr. Rouleau: Mr. Chairman, I would ask you to have the hon. member for Quebec South (Mr. Flynn) withdraw the expression "dirty fellow" he just used concerning the member for Hull.

Mr. Speaker resumed the chair, and the chairman of the committee made the following report:

He was invited to withdraw these remarks but persisted in his refusal to do so. I am therefore making the present report to you, Mr. Speaker.

Mr. Speaker: I can only consult with the chairman of the committee, or perhaps hon. members who sat in the committee would know. There was no interruption, I take it, in the reporting of the proceedings.

Mr. Pickersgill: I would have thought, sir, that it was not competent to the house to inquire what went on in the committee beyond the report that was made to the house by the chairman.

Mr. Churchill: That being the case, under the circumstances, Mr. Speaker, I have no other course than to move, seconded by the Minister of Mines and Technical Surveys (Mr. Flynn):

That the hon. member for Hull (Mr. Caron) be suspended from the house for the remainder of this day's sitting.

Mr. Chevrier: Mr. Speaker, I desire to say something on this motion, if I may.
