CANADIAN NATIONAL RAILWAYS**

On the orders of the day:

**Mr. D. M. Fisher (Port Arthur):** I should like to ask a question of the Minister of Transport. Is it the intention of the minister to allow the house to examine the annual report of the Canadian National Railways before the house proceeds with motion No. 8 on the order paper under government business, which introduces a resolution relating to Canadian National Railways and its financing?

**Mr. Speaker:** In view of the fact that the order of business has been announced for the next eight days and this particular motion cannot come before the house before the expiry of that time, I do not think there is any urgency with regard to the information sought by the hon. member.

**Mr. Fisher:** There are a number of organizations including pensioners of Canadian National Railways, who wish to know well ahead of time if the annual report is up for review because, like last year, they want to have witnesses at the hearing. For that reason I should like to pin down, if possible, some kind of date for the appearance of the president of Canadian National Railways in Ottawa.

**Hon. Leon Balcer (Minister of Transport):** Mr. Speaker, it is our intention to have a committee on the Canadian National and Trans-Canada Air Lines sit at this session. So far as the date of the sitting is concerned, it is too early for me to tell. In so far as the motion is concerned, the date upon which we will proceed with that will be announced by the house leader at the proper time.

**HEALTH AND WELFARE****POLIOMYELITIS—CONTINUATION OF USE OF  
SALK VACCINE**

On the orders of the day:

**Mr. Stanley Haidasz (Parkdale):** I should like to ask the Minister of National Health

and Welfare whether, in view of the disappointment and confusion caused by the minister's directive to postpone the free mass immunization against poliomyelitis with oral Sabin vaccine, he has any intention of giving a directive for the continuation of the free mass immunization against poliomyelitis with Salk vaccine at the earliest possible moment?

**Hon. J. W. Monteith (Minister of National Health and Welfare):** Mr. Speaker, I think it is quite misleading to suggest that the Canadian people lack the utmost protection against polio that we can provide. As I indicated when the Sabin vaccine program was temporarily deferred last month, the incidence of this disease is extremely low at the moment. My advisory committee in this field recommended that the Salk vaccine program continue, and felt that Sabin vaccine could well be used if the need arose through any local outbreaks of polio. This approach was felt by the committee to be the soundest one to follow under present circumstances.

**REPORTED APPROVAL OF UNSAFE LIFE JACKETS**
