STATEMENT BY MINISTER OF JUSTICE ON FEDERAL
TAXATION OF PROVINCIAL CROWN COMPANIES DEVELOPING
RESOURCES—CONSULTATION WITH PROVINCES

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I have a question for the Prime Minister. Last night in the House the Minister of Justice indicated that he strongly favoured federal taxation of Crown corporations if they are used by provinces to develop their resources. Was the Minister of Justice speaking simply as an individual at that time or was he stating government policy?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the hon. member is not stating what the minister said. I read his speech just a few minutes ago. He did not say he strongly favoured that. I don't know why the leader of the New Democratic Party places those words in the minister's mouth. He said it was possible.

Some hon. Members: Hear, hear!

Mr. Broadbent: Mr. Speaker, it is a pleasure to learn that the Prime Minister is paying attention to debates in the House. It is very reassuring. Whether the minister strongly favoured it or not is a matter of judgment. If you read his text and argument, I think my interpretation is an understatement. The Prime Minister still has not answered my question. Is this government policy or is it not?

Mr. Trudeau: Mr. Speaker, the Minister of Justice said it was possible to do that. That is all he stated and I support him in that.

Mr. Broadbent: If the government embarks on such a policy, will the Prime Minister inform the House whether one result would be extending the idea to taxing provincial departmental activities in the resource sector if they took over certain developments independent of using a Crown corporation. Is the federal government considering that as well?

Mr. Trudeau: Mr. Speaker, I am sure you realize the question is hypothetical.

Mr. Trudeau: Mr. Speaker, if the provinces consult us before nationalizing industries, we will return the same courtesy to them.
