AGREEMENT PERMITTING ESTABLISHMENT OF MATANE PAPER  
MILL—GOVERNMENT POSITION

**Mr. Jean-Claude Malépart (Montréal—Sainte-Marie):** Mr. Speaker, I had a chance to speak to the Quebec Minister of Natural Resources, and I get the feeling that the two of them are not on the same wavelength.

I would like to know from the Minister, and I am asking the same question to the Quebec Minister, whether the Minister will have signed the agreement by Wednesday in order that the Matane paper mill can proceed? Yes or no?

**Hon. Sinclair Stevens (Minister of Regional Industrial Expansion):** Mr. Speaker, I will reiterate what I have said already. It takes two to sign an agreement. The Norwegian company has indicated that it will not be in a position to sign any agreement or negotiate seriously with respect to this project until sometime in May. As far as the Minister from Quebec is concerned, I have had repeated conversations with him, both in person and by telephone. Negotiations are ongoing as to what might be the federal position and as to what might be the Quebec position in the event that the Norwegian company wants to go ahead with this project sometime in May.

KOREAN BANK'S REPORTED LOAN TO COMPANY FORMERLY  
CONTROLLED BY MINISTER

**Mr. Steven W. **Hon. Erik Nielsen (Deputy Prime Minister and Minister of National Defence):** Mr. Speaker, this is a matter which carries at least the inference of a conflict of interest. On behalf of the Government I can inform the Hon. Member that, having discussed the matter with the Minister, I am absolutely satisfied that he has met the very exacting demands imposed by the previous conflict of interest guidelines and by the existing conflict of interest guidelines.
