A message was delivered by the Gentleman Usher of the Black Rod as follows:

Mr. Speaker, the Honourable Deputy to the Governor General desires the immediate attendance of this honourable House in the chamber of the honourable Senate.

Accordingly, Mr. Speaker with the House went up to the Senate chamber.

And being returned:

Mr. Speaker: Order. I have the honour to inform the House that when the House went up to the Senate Chamber, the Deputy Governor General had been pleased to give in Her Majesty's name the Royal Assent to the following Bills:

Bill C-43, an Act respecting the Canada-Nova Scotia Agreement on Offshore Oil and Gas Resource Management and Revenue Sharing and to make related and consequential amendments—Chapter No. 29.

Bill C-30, an Act to amend the Bank Act—Chapter No. 30.

Bill C-24, an Act to amend the Financial Administration Act in relation to Crown corporations and to amend other Acts in consequence thereof—Chapter No. 31.

Bill C-51, an Act to implement a convention between Canada and the United Kingdom of Great Britain and Northern Ireland providing for the reciprocal recognition and enforcement of judgements in civil and commercial matters—Chapter No. 32.

Bill C-54, an Act to amend the Public Service Superannuation Act—Chapter No. 33.

Royal Assent

Bill C-53, an Act to establish a National Park on the Mingan Archipelago—Chapter No. 34.

Bill S-11, an Act to implement conventions between Canada and the Republic of Tunisia, Canada and the People's Republic of Bangladesh, Canada and the United Republic of Cameroon and Canada and the Democratic Socialist Republic of Sri Lanka, an agreement between Canada and Kenya and conventions between Canada and the Arab Republic of Egypt, Canada and the Republic of the Ivory Coast and Canada and Sweden for the avoidance of double taxation with respect to income tax—Chapter No. 35.

Bill C-252, an Act to grant access to records of the Special Committee on the Defence of Canada Regulations—Chapter No. 36.

Bill C-32, an Act to establish the Canadian Institute for International Peace and Security—Chapter No. 37.

Bill C-33, an Act to amend the Western Grain Stabilization Act—Chapter No. 38.

Bill C-34, an Act to amend the Canada Labour Code and the Financial Administration Act—Chapter No. 39.

Bill C-58, an Act to correct certain anomalies, inconsistencies, archaisms and errors and to deal with other matters of a non-controversial and uncomplicated nature in the Statutes of Canada—Chapter No. 40.

Bill S-16, an Act to revive Stadacona Mines (1944) Limited and to provide for its continuance under the Canada Business Corporations Act.
