#### HUMAN RIGHTS

##### CO-OPERATION BETWEEN DEPARTMENT OF LABOUR AND ONTARIO COMMISSION

**Mr. Lincoln M. Alexander (Hamilton West):** My question is for the Minister of Labour. Is his department co-operating with and/or having discussions with the Ontario Human Rights Commission in the province of Ontario which is at present investigating charges of discrimination in the national capital area? If so, to what extent? I ask this question notwithstanding the fact there may be some constitutional grounds on which this government feels it should not be involved.

**Hon. Bryce S. Mackasey (Minister of Labour):** Mr. Speaker, the hon. member has quite aptly pointed out the constitutional problem. I am sure he will be pleased to know there is the maximum degree of communication between my department and the various agencies charged with this responsibility in the provincial field. There is the maximum degree of co-operation and communication despite constitutional barriers.

**Mr. Alexander:** A supplementary—

**Mr. Speaker:** Order, please. We have just about reached the end of the question period. I hoped the Chair might have the opportunity of recognizing two or three other members quickly.

**Mr. Alexander:** On a point of order, Mr. Speaker, because I have been so quiet for the past three or four days I thought I would have the opportunity to ask a supplementary. Am I to take it from the minister's answer that at the present time during these investigations his department is in dialogue and having consultations with representatives of the Ontario Human Rights Commission?

**Mr. Mackasey:** I am sure the hon. member will agree with me that no responsible department, federal or provincial, would want to hide behind the constitution in an area as important as discrimination. We are not trying to evade our responsibility. We feel we have a moral obligation to communicate and co-operate with all provinces in this sensitive area.
