A ROYAL SALUTE TO DUKE AT ST. CATHARINES

Daughters of Empire Present Governor-General With History of Welland Canal.

St. Catharines, May 11.—A salute of 21 guns by the Seventh Field Battery and appropriate music by the Nineteenth Regiment Band announced the arrival of His Royal Highness the Duke of Connaught and party at the Grand Trunk depot, St. Catharines, at 10:30 o'clock this morning, where, after being met by Mayor Pettie and Alderman Chaplain, and inspecting a guard of honor from the Nineteenth Regiment, the vice-regal party, accompanied by a mounted escort from the Second Dragoons, was driven through a lavishly-decorated route to Montebello Park, where an official address of welcome was presented to the Governor-General to which he replied.

Book and Bouquets.
Miss Catherine Welland, Merritt, granddaughter of the late Hon. William Hamilton Merritt, representing the Daughters of the Empire, presented a hand-embroidered, richly-bound and illustrated History of the Welland Canal. Bouquets were presented to Princess Patricia by Miss Pettie and Miss Williams.

Patriotic songs were sung by the school children and massed choirs.

This afternoon an inspection is being made of the work on the Welland ship canal. Sergt-Major Walter Legg, of the Seventh Field Battery, received a long service medal from the hands of the duke.

Over 25,000 people were on the streets, a half-holiday having been declared and observed.

COLORADO MINES TO REMAIN CLOSED DOWN

Secretary of War Announces That None Will Be Permitted to Open Yet.

Washington, May 11.—No mines will be permitted to reopen in the Colorado strike district for the present, Secretary of War Garrison announced today. He denied that orders had been issued forbidding importation of strike-breakers, but explained that while the situation remained threatening the mines not already running probably would be kept closed until, in his judgment, their reopening would precipitate no further trouble.

"It makes no difference whether strike-breakers are imported or whether the labor is on the ground," said the Secretary of War. "The question is whether their employment would start trouble. We are not going to permit anything that would aggravate the situation. The mines will be allowed to reopen just as soon as conditions warrant."

YOUTH CHARGED WITH KILLING THREE OTHERS

Ocala, Fla., May 11.—The youth with killing three other youths with a shotgun, Preston Williams, an 18-year-old youth, is in jail today. The victims were Elbert and Robert Gay, brothers, and Jesse Sumner, all members of prominent families.

The three boys were killed yesterday as they drove away from the Williams home, near here.

TUGMEN WILL WORK PENDING CONFERENCE

Buffalo, N. Y., May 11.—The tugs of the Great Lakes Towing Company's fleet will go into commission today after being tied up for three weeks. The men refused to remain on the tugs continuously, working six-hour shifts as required by the company under its interpretation of the twelve-hour navigation law. They asked for twelve hours' continuous duty, followed by twelve hours' off the boats. The tugmen agreed to return to work pending the result of a conference to be held at Cleveland tomorrow.
