Dr. Seymour, at the urgent request of the new Diccese of Springfield, has reconsidered his previous declination, and has finally accepted the Bishopric to which he had been elected.

THERE is a difference between a Spire and a Steeple. A Spire is the high pyramidal roof of a Tower. A Steeple is the tower of a church with all its appendages, as turret, octagon and spire.

PROGRESS IN THE YORUBA MISsion.—The baptisms in the Yoruba mission last year numbered 409. viz., 202 adults and 207 children. Of the adult baptisms, 65 were at Lagos, 38 at Ebute Meta, 38 at Abeokuta, 29 at Abidan, besides a few at the smaller stations. native Christian adherents have increased by 1.100 and the communicants by 300, in two years, the figures being now 5,845 and 2,024.
