QUEBEC—REQUEST FOR POSTPONEMENT OF CONFERENCE

On the orders of the day:

Hon. Robert L. Stanfield (Leader of the Opposition): I should like to ask the Prime Minister a question arising out of the illness of the Prime Minister of Quebec and the report that the government of Quebec is seeking to have the federal-provincial constitutional conference postponed. What is the position of the government of Canada with regard to this reported request from the government of Quebec?
