ESTABLISHMENT OF WATER QUALITY MANAGEMENT AREAS

# Question No. 141-Mr. Harding:

- 1. In what areas does the government anticipate establishing Water Quality Management Areas as provided for in the Canada Water Act?
- 2. Have any such areas been designated to date?
- 3. Has the government entered into discussions with any provincial or local governments or any other groups in order to initiate the establishment of such areas?
- Hon. J. J. Greene (Minister of Energy, Mines and Resources): 1. The Government anticipates that water quality management areas will be established, as provided for in the Canada Water Act, in any part of the nation where water quality management has become a matter of urgent national concern. Where the waters involved are located within one or more of the provinces the establishment of such management areas normally will take place by agreement between or among the federal and provincial governments concerned.
- 2. No such management areas have been designated to date; that part of the Canada Water Act providing for establishment of such management areas became law on September 30, 1970.
- 3. Yes. Arrangements have been made with each province to establish intergovernmental committees to maintain continuing consultation on water resource matters. Most of these committees were established in anticipation of the Act coming into force; and they have met on several occasions in connection with the formulation, coordination and implementation of water policies and programs. The possible establishment of water quality management areas is only one element in this policy and program review process.
