RESEARCH ON TRAFFIC SAFETY WARNING AND CONTROL DEVICES

Question No. 114-Mr. Skoberg:

- 1. Did the Minister of Transport call for public tenders throughout Canada for a contract into research on traffic safety warning and control devices and, if not, for what reason?
- 2. If public tenders were called, how many bids were received and from whom?
- 3. Were public tenders called throughout Canada for the evaluation of the effectiveness of safety campaigns awarded to Peat, Marwick and Company, of Toronto and, if not, for what reason?
- 4. If public bids were called, how many bids were received and who made the decision on the successful tender?
- 5. What firms, individuals or associations make up the Traffic Inquiry Research Foundation of Canada, Ottawa, that is preparing a study to review the type of knowledge in Canada concerning the role of alcohol in road vehicle safety?
- Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): 1. Public tenders were not called by the Department for providing research on traffic safety warning and control devices as public tenders are not considered an acceptable means of engaging professionals to provide expert services. In this case, five engineering consulting firms, known to possess the capability to undertake this project, were invited to submit proposals.
- 2. Although public tenders were not called, proposals were received from firms located in Montreal, Toronto, Willowdale and Edmonton.
- 3. Six consulting firms, known to possess the capability to undertake an evaluation of the effectiveness of safety campaigns, were invited to submit proposals. Proposals were received from five of those firms.
- 4. The successful firm was selected by a committee within the Department on the basis of the firm's appreciation of the problem, the proposed methods of investigation, time scheduling, costs, and experience of personnel in similar work.
- 5. Traffic Injury Research Foundation of Canada is a non-profit chartered foundation supported by donations including grants from the Department of National Health and Welfare and several Provincial Governments. Founding members include, among others, the Royal College of Physicians and Surgeons, Defence Research Board and Medical Research Council. Individual members include professionals from many disciplines.
