POSSIBILITY OF FURTHER MEASURES TO DEAL WITH FOREIGN INVESTMENT

Mr. David Lewis (York South): Mr. Speaker, the Minister of Industry, Trade and Commerce is reported in one of the morning newspapers to have stated to some journalists that there were other measures to deal with foreign ownership and foreign investment which the government would eventually bring in. May I ask him what measures he had in mind?

Mr. Speaker: Perhaps the question might be asked directly. The hon. member knows the rule about referring to statements made by a minister outside the House. Having said that, we can assume that the question has been asked directly.

Mr. Lewis: Mr. Speaker, I was asking the minister whether he would tell the House what other measures in respect of foreign ownership and foreign investment the government is contemplating, if it is contemplating any, and when we may expect such measures to be announced?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, I was not really adding anything to what was said by the Minister of National Revenue when he made his announcement. Yesterday, for example, when the Leader of the Opposition asked me whether we were contemplating moves having to do with participation in Canadian industry I said there was, among the five factors to be used in deciding on takeovers under the bill which has been introduced, one called "participation". When a takeover is being studied by my department the degree of participation by Canadians in that particular instance would be a consideration taken into account in determining whether the takeover was an allowable one or not.

Mr. Lewis: From that I gather the minister was not saying anything to the press.

MONITORING UNIT TO EXERCISE SURVEILLANCE OVER FOREIGN TAKEOVERS UNTIL BILL BECOMES LAW

Mr. David Lewis (York South): Mr. Speaker, may I ask the minister this question: Would he inform the House whether he has set up or is contemplating setting up a monitoring unit of some sort to have some surveillance over foreign takeovers that might take place during the interim period until the bill which was introduced yesterday becomes law?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, as the Prime Minister said the other day, the law will not be retroactive, but I expect that people who intend to proceed to important takeovers in the meantime or in the interim period will keep me informed.

Mr. Lewis: I have a further supplementary, Mr. Speaker. May I ask the minister whether he has given thought concerning how he will act and what will happen in the case of takeover negotiations that have been completed when the law comes into force but completion has not yet been formalized? Will the law apply to such situations, or what exactly will he do with that kind of situation?

FOREIGN OWNERSHIP—SUGGESTED DEFERMENT OF TRANSFER OF CANADIAN SHIPS TO FOREIGN REGIS-TRY UNTIL REVIEW POSSIBLE WHEN BILL BECOMES LAW
