family allowances and massive cut-backs in the public commitment to child benefits are an unfair attack on women and families with children, especially single-parent mothers. Moreover, they call upon Parliament to reinstate full indexation of universal family allowances and rescind unfair tax increases.

Mr. Jim Fulton (Skeena): Mr. Speaker, I have several petitions to bring to the attention of the House today. The first is from the Delta, Burnaby, Richmond and Vancouver areas of British Columbia. The petitioners are very concerned that deindexation of universal family allowances and cut-backs in the public commitment to child benefits are an unfair attack on women and families with children, especially single-parent mothers. They call upon this House to do whatever it can to reinstate full indexation.

The second group of petitions is from all over Ontario and they bear a large number of signatures. The petitioners are concerned about budget hand-outs such as the \$500,000 in tax-free capital gains, RRSP deductions and billions of dollars going to the banks while at the same time the universal family allowance is being cut back. I am pleased to provide these to you today, Mr. Speaker.

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, I also have quite a number of petitions from British Columbia and the Maritime provinces. The petitioners ask for reinstatement of full indexation to family allowances. The petitions from British Columbia include the communities of Surrey, New Westminster, Coquitlam, Vancouver, North Vancouver, South Canbrook, Kimberley, Invermere, Haney, Richmond, White Rock, Burnaby, Port Alberni, Dawson Creek, Saltspring Island, Surrey and many from the City of Vancouver. There are also petitions from Delta, Nelson, Castlegar, Ganges on Saltspring Island, Port Moody, Fruitvale, Port Hardy, Lac-la-Hache, Richmond, Sechelt, Salmon Arm, Kitimat—

Mr. Frith: Sounds like a bus schedule.

Ms. Mitchell: It does sound like a bus schedule but they say that people all over British Columbia are concerned.

The second group of petitions are from Lunenburg and Bridgewater, Nova Scotia. There are petitions from Dover, Riverview and St. John's, Newfoundland. There are also quite a number from a number of different communities in Nova Scotia. They all protest Bill C-70.

Hon. Douglas C. Frith (Sudbury): Mr. Speaker, I, too, have a number of petitions which ask the Government to reverse itself on the plan to deindex family allowances. The petitioners reside in Labrador and Quebec. There are petitions from the ridings of Sudbury, Gander-Twillingate, Nickel Belt, and Victoria, as well as from the Okanagan and Esquimalt areas of British Columbia.

CALL FOR WITHDRAWAL OF BILL C-70

FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF TAX INCREASES

Mr. Rod Murphy (Churchill): Mr. Speaker, I also have the honour to present a number of petitions from a number of communities in Nova Scotia, including Halifax, Dartmouth, Sackville, Pugwash, Wentworth, Truto and Springhill. The petitioners ask this House to reinstate full indexation of universal family allowances and rescind unfair tax increases from the last Budget.

I also have the honour to present a petition from my own riding, specifically Norway House, where a number of native people have again expressed their concern over the Government's intention to destroy universal family allowances absolutely by partial deindexation of that very necessary source of income to the people of that community.
