B. at Earltown, Colchester Co., N.S., 11th Sept., 1847. Ed. there, at Truro, and at New York. M., at Dartmouth, 10 Nov., 1875, Catherine Campbell, youngest dau. of Gilbert Sutherland, Esq. Has been twice Presdt. of the Cape Breton Medical Soc. and Vice-Presdt. of the N. S. Med. Soc. Is a mem. of the Board of Health and Physician to several of collieries in Cape Breton. First returned to Ho. of Assem. at last g.e. A Liberal-Conservative.—Reserve Mines, Cape Breton.

MCKINNON, JOHN. (Inverness.)

Family belongs to the McKinnons of Skye, Scot. Second s. of Lachlin McKinnon, Esq., who came to Cape Breton from North Uist, 1828, by Annie McLean, his wife. B. at Whycocomah, N.S., 14 July, 1832. Ed. at the Presbyterian Coll., Halifax. M., Harriet, dau. of the late D. McQueen, Sydney, C.B. Is a farmer and trader. Was a member of the Ex. Council, N.S., from 8 May, 1875, to 15 Oct., 1878. First returned to Ho. of Assem. at g.e. 1874; an unsuccessful candidate at g.e. 1878 and 1882, re-elected at last g.e. A Liberal.—Whycocomah, N.S.
