TUPPER AND "THE TRUNK." The "Stretcher's" Statements Deals

London, April 3.—The most important passages of the Grand Trunk report, issued to-night, relate to Tupper's attack on the company. The directors state that when the elections were pending they inthe elections were pending they in-structed the general manager that the board had nothing to do with politics or with either party, but only with the interests of the company. In accordance with this policy, Mr. Seargeant, when Sir Charles Tupper called on him, declined to make any announcement to the employes with regard to the elections. The directors say they cannot too strongly deprecate Tupper's action and the language which he permitted himself to employ, especially in view of the fact that as High Commissioner his duty was to fairly represent all interests of the Dominion and not attack a company which has for a long time sent all interests of the Dominion and not attack a company which has for a long time and is still expending large sums on its vast railway system, resulting in enormous bene-fits to the Dominion and which cannot but

fits to the Dominion and which cannot but tend in the future to increase its prosperity. The board had good reason to be satisfied with Mr. Seargeant's attitude, which will certainly redound in future to the benefit of the company. At the meeting on Tuesday week Sir Henry Tyler will reply fully to Tupper's statements. SLIGO, April 3.—Mr. Michael Davitt, editor of the Labor World, sent a dispatch from Sligo to that paper saying that the polling commenced punctually at 8 a.m., workingmen voting at that early hour. The constituency is divided into two polling districts, in which there are fifteen polling booths. In some of the districts the voters are compelled to travel seven miles. The Parnellites admit that they are beaten. The Tories voted for the Parnellite candidate, in spite of the fact that the Conservate Club advised them to abstain from voting. There are about 700 voters in the constituency. Of that number it is believed Mr. Dillon had 500 votes. But for this support, Mr. Collery would have won by nearly 2,000 majority. The local Orange lodge supported the Parnellite candidate.

For the Murder of William O. Rowe, of Metcalfe.

The murder case of the Queen vs. Robert Murray was taken up on the court resuming yesterday morning.

The prisoner, on being brought into the court room, seated himself in a corner of the prisoner's box, and leaning his head on his left hand, watched the proceedings, although not with any great keenness. The court room was crowded long before the jury was sworn, and when the case was opened the doors on the side were locked to prevent further crowding. Several ladies were present, and carefully watched the case during the entire day. Among them were the wite and mother-in-law of the prisoner. Mrs. Murray was dressed in black and was heavily veiled. In company with her mother she sat at the table with the counsel for the defense and faced the jury box throughout the session.

Mr. E. Meredith, as counsel for the prisoner, exercised freely his right of challenging, and rejected nineteen of the panel. The jury as sworn was made up of: J. H. Alexander, Adelaide (foreman); J. To bring in a verdict of manslaughter, the speaker pointed out that the jury would have to deal with the fact that the prisoner had a deedly weepon in his hand and had time to think over what he had afterwards committed.
