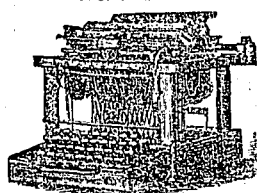

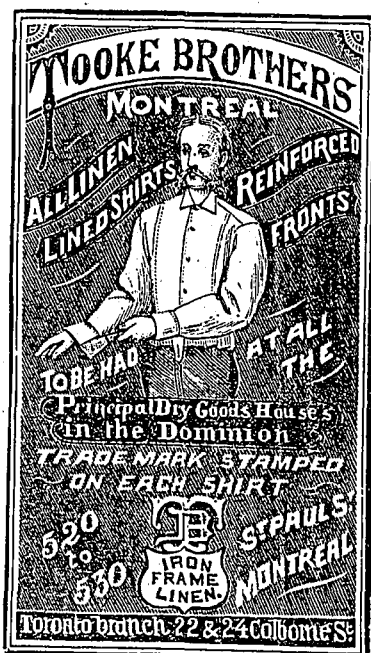

W. H. MORLEY, general trader, Sydney, C.B.,
has assigned to Messrs. T. & E. Kenny,
Halifax, with liabilities amounting to \$9,000.—
Jos. P. Rogers, general dealer, Weldford
Station, N.B., has closed up business.

THREE well-known business men of Hamilton,
Ont., have gone to their long homes,—Edward
McGivern, carriage goods; Joseph Mills (of Jos.
Mills & Son), hatter and furrier, and Henry
Bauer, wine merchant.

SINCE our last issue two lumbermen at Clyde
River, N.S., a liquor dealer at Gabarus, same
Province, and a tailor of Halifax, have given
bills of sale.—McKean & Co., general store,
Vogler's Cove, are reported as having left the
precincts.

MISS L. IRVINE, milliner, Sherbrooke, Que.,
has offered to compromise at 35c on the dollar,
secured; expenses appear to have been dis-
proportionately heavy during the three years
in which the business has been carried on;
liabilities \$2,000; assets \$1,500.

AFTER about 15 years of business, Douglas
H. Story, Halifax, N.S., has assigned, with
liabilities \$18,000, of which \$4,635 are preferred;
the assets are placed at \$5,000, but are probably
not worth more than \$3,000; the insolvent's
position is attributed in some degree to his
mistaken kindness as endorser.

A CHANGE has taken place in the wholesale
firm of Samson, Kennedy & Gemmel, Toronto,
by the retirement of Alex. Gemmel and Alex.
McGaw. The remaining partners continue
under the style of Samson, Kennedy & Co.—
D. S. Keith has retired from the plumbing firm
which bore his name, same city.

SPENCER, Beddoe & Co., wholesale hardware
merchants, Hamilton, have dissolved.—Chas.
W. Tinsling has been admitted to a partnership
in the firm of Archdale, Wilson & Co., drug-
gists, that city.—Glover Harrison has been ad-
mitted as special partner for \$25,000 in the
wholesale firm of Wm. Thomson & Co., To-
ronto.

THOS. P. HAYDEN is a very young man who
began the grocery business in Prescott, Ont.,
some two years ago, with some assistance from
a maternal relative. He assigned to a Montreal
man last week, showing liabilities of \$3,400
and assets estimated at \$2,500. At last accounts
he was endeavoring to effect a settlement at 60
cents in the dollar.
