

Mr. Gordon, a Member of the King's Privy Council, laid before the House, —Copies of Orders in Council passed under the provisions of the Relief Act, 1933, as follows:—

Order in Council, P.C. 140, dated 5th February, 1934: authorizing payment to the Province of Nova Scotia of the sum of \$13,508 for Provincial Highways.

Order in Council, P.C. 202, dated 5th February, 1934: authorizing payment to the Province of Nova Scotia of the sum of \$15,024.54 for municipal direct relief.

Order in Council, P.C. 203, dated 5th February, 1934: authorizing payment to the Province of Quebec of the sum of \$21,609.30 for direct relief.

Order in Council, P.C. 204, dated 5th February, 1934: authorizing payment to the Province of Quebec of the sum of \$5,728.24 for municipal direct relief.

Order in Council, P.C. 205, dated 5th February, 1934: authorizing payment to the Province of Quebec of the sum of \$5,807.23 for relief settlement.

Order in Council, P.C. 206, dated 5th February, 1934: authorizing payment to the Province of Quebec of the sum of \$2,031 for road works in Gaspé County.

Order in Council, P.C. 207, dated 5th February, 1934: authorizing payment to the Province of Quebec of the sum of \$938 for labour on Provincial Highways.

Order in Council, P.C. 210, dated 5th February, 1934: amending Order in Council, P.C. 2329, dated 13th November, 1933, respecting road works in Gaspé County, not to exceed the sum of \$2,500.

Order in Council, P.C. 211, dated 5th February, 1934: authorizing payment to the Province of Ontario of the sum of \$450,303.54 for direct relief.

Order in Council, P.C. 212, dated 5th February, 1934: authorizing payment to the Province of Ontario of the sum of \$589.31 for relief settlement.

Order in Council, P.C. 213, dated 5th February, 1934: authorizing payment to the Province of Ontario of the sum of \$75,870.63 for municipal works.

Order in Council, P.C. 214, dated 5th February, 1934: authorizing payment to the Province of Manitoba of the sum of \$2,065.09 for relief settlement.

Order in Council, P.C. 215, dated 5th February, 1934: covering relief work in the town of Winnipeg Beach, Manitoba, making retroactive to October 1, 1933, certain provincial works not exceeding the sum of \$336.
