By Mr. Stevens:—Address to His Excellency the Governor General, for a copy of all correspondence, letters, telegrams, Orders in Council appointing Royal Commission, report if any of the said Royal Commission, copy of the evidence taken by the said Royal Commission, and all other documents and papers appertaining thereto, in connection with an item appearing in the Estimates for the fiscal year ending March 31, 1937, as Vote No. 227 and reading as follows:-

"To reimburse Peter R. Jack and Chas. A. Ackhurst, onetime Harbour Commissioners at Halifax, for expenses incurred by them in connection with the inquiry into the administration of the Halifax Harbour Commission in 1930.....

Also a copy of all letters, telegrams, or other correspondence or documents passing between any member of the Government or official of the Government and the said Peter R. Jack or the said Chas. A. Ackhurst, or their counsel during the years 1930 up to February 19, 1936.

By Mr. Wermenlinger:—Order of the House for a copy of all correspondence and other documents respecting the dismissal of Michel Bedard, as chauffeur in the employ of the Public Works Department at Quebec, covering the period from October 1, 1935, to date.
