IMPORTATION OF BATHROOM FIXTURES, TORONTO

Question No. 555-Mr. Howard:

Does the government or any agency or branch thereof have any knowledge that American Standard Products (Canada) Ltd. of Toronto is importing bathroom fixtures into Canada for the purpose of having them given the Canadian standards association (CSA) stamp of approval so they may be used to circumvent the effect of a strike at its Lansdowne plant by the international brotherhood of potters and, if so, what action does the government contemplate taking to prevent this?

Answer: The Canadian Standards Association (CSA) stamp of approval is indicative only of conformity with a set of voluntary standards established by the particular industry itself. The government of Canada does not enforce the provisions of the code with respect to the entrance of imported goods. The code becomes mandatory only by action by provincial or municipal authorities.
