REPORTED HAZARDS OF SHELL VAPONA INSECTICIDE STRIP

Mr. Barry Mather (Surrey): Mr. Speaker, I have a question to direct to the attention of the Minister of National Health and Welfare or the Minister of Consumer and Corporate Affairs. Can either minister indicate whether an inquiry or study is being made at this time into the reported health hazards of the household insecticide-killing strip produced by the Shell Oil Company, the Vapona strip?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, actually the question should have been referred to the Minister of Agriculture under whose jurisdiction the control of pesticides falls. Very extensive tests of this product are being conducted in consultation and co-operation with my department and the Department of National Health and Welfare.

Mr. Mather: Can the minister indicate when the results of such tests might be available?

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, we are sending out a press release today and I would be happy to send a copy to my hon. friend.

STE. SCHOLASTIQUE-EXPROPRIATION OF LAND

I should advise the House that this is not the first time this has happened, and indeed they have not been much greater this year than in previous years. I will be glad to give the hon. member the other details as to the countries and the number of cargoes as soon as I have them.

Mr. Korchinski: Since it appears that the inspection is at fault here, is the government prepared to accept the responsibility?

Mr. Olson: Mr. Speaker, the inspection service is not at fault.
