worse situation than they are at present with starvation a reality, something we do not have in this country. The production of some of our plants this year has increased by a quarter of a million tons. Plants, to my knowledge, have been operating seven days a week, 24 hours a day to produce the products needed here and in other parts of the world. I will be making a complete statement on this matter shortly.

Mr. Speaker: Order, please. I think I should bring to the attention of hon. members that a large number of members are rising on both sides of the House to ask questions and supplementaries. #### EGGS-IMPOSITION OF IMPORT CONTROLS

Mr. Jack Murta (Lisgar): Mr. Speaker, I should like to direct a question to the Minister of Agriculture. Now that Bill C-4, the Export and Import Permits Act amendment, has been passed, I should like to ask whether the bill is to be used, in what manner it will be used, whether there will be controls, and what kind of controls will be imposed for the situation immediately at hand, which is the egg problem.

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, there should be a release in every member's mailbox at this time indicating that permits will be required for imports of turkeys and eggs as of midnight tonight, May 8, 1974.

Mr. Nystrom: Can the Minister of Finance assure the House that he will be giving us that figure within the next few days and, preferably, before the end of this month?

Mr. Turner (Ottawa-Carleton): If there is a House then, I can give that assurance.
