Mr. Gillies: Mr. Speaker, may I rise on a question of privilege. I may have misspoken when I said "CANDU". I do know that it was a research reactor, and I stand corrected. However, I am sure that the hon. member knows that it was a research reactor which did come from Canada, which did produce plutonium, and which did eventually lead to the bomb.
