##### REQUEST FOR BAN ON FOREIGN PUBLICATIONS SLANDERING CANADIAN PUBLIC FIGURES

**Mr. Jesse P. Flis (Parkdale-High Park):** Madam Speaker, my question, which was raised in the Ontario legislature but appropriately referred to this House, is for the Secretary of State for External Affairs.

In light of the fact that last week this House approved a motion expressing its strong disapproval for the publication *News from the Ukraine*, a Soviet publication distributed in Canada which deliberately spread hate literature about a former member of this House, the former member for Parkdale, and considering that this publication compared Mr. Shymko with the would-be assassins of Pope John Paul II and President Reagan, and in view of the fact that this kind of malicious propaganda by a foreign publication against a former member of this House cannot go unchallenged, what appropriate steps is the minister prepared to take to ban such publications from invading our borders and attempting to destroy the reputations of certain Canadian statespersons?

**Hon. Mark MacGuigan (Secretary of State for External Affairs):** Madam Speaker, last week I joined this House in supporting the motion which was passed. The statements made about Mr. Shymko were indeed deplorable.

We, being a free society, do not ban publications at the border. We do not have the power to act in that way but we have power, under our domestic legislation as in the anti-

propaganda legislation for instance, to take action against publications which may attack individuals. I have written to Mr. Shymko advising him along those lines, and I have no doubt that he is seeking advice from other quarters as well.

#### CANADIAN ARMED FORCES

##### COURT-MARTIALLING OF ORDINARY SEAMAN

**Hon. Allan B. McKinnon (Victoria):** Madam Speaker, I have given the Minister of National Defence notice of my question. Ordinary Seaman Emery was court-martialled in early January and sentenced to six months detention and fined \$750 on a drug related charge. The detention portion of the sentence was suspended by the court. Five weeks later, the commander, Pacific Command, using his authority to remit, remitted the fine but lifted suspension on three months of the detention, thus greatly increasing the punishment. Can the minister assure the House that he will take steps immediately to rectify this miscarriage of justice?

**Hon. J. Gilles Lamontagne (Minister of National Defence):** Madam Speaker, I thank the hon. member for advising me of the question ahead of time. I am well aware of the case of Private Emery. As soon as I got the telegram from his lawyers—and I think the hon. member received a copy—I asked that the proceedings of the court martial be sent to NDHQ to be reviewed quickly.

Despite the strict discipline that we must have in the military, and also the very strict regulations, I am always careful to ensure that the fundamental rights of all members of our forces are well preserved.
