Mr. McDermid: Mr. Speaker, that is not where the loan responsibility rests, just to give the information to the Minister of Finance. It rests with the Department of Trade, but there is not a soul from that Department over there and it was the Minister of Finance who announced it.

ACTIVATION OF FUND

Mr. John McDermid (Brampton-Georgetown): Will the Minister make a commitment to encourage his colleagues to activate that fund so that Indians can start small businesses, and have proper funding which would help the unemployment situation which is tragic with the Indian people?

Mr. Speaker: The Chair has difficulty accepting a supplementary in view of the responsibility of another Minister for the program, according to the rules and practices of the House.

Members to ask questions without supplementaries during the last five or ten minutes of each Question Period. I would like to commend the Speaker and ask him to continue the practice.

Mr. Speaker: The Hon. Member, however well intentioned, is out of order at this point.
