XXIV.

Conventum mutuo est, quod Pacis hodie conclusæ inter *S. Regiam Majestatem Christianissimam*, & *S. Regiam Majestatem Lusitanie*, Conditiones omnes & singulae huius Pactis confirmantur; earumque Sponsionem seu Garantiam in se recipit *S. Regia Majestas Magnae Britanniae*, quo tutius, inviolatiusque observetur.

XXV.

Traçtatus Pacis hodie initus inter *S. Regiam Majestatem Christianissimam*, & *Regiam suam Celsitudinem Sabaudie Ducem*, in hoc Traçtatu specialitèr, tanquam pars ejus essentialis, inclusus est & confirmatus, perinde ac si eidem verborum insertus esset; declarante per expressum Regiâ suâ Majestate *Magnae Britanniae*, Sese ad promissas in eodem Assertionis & Garantiae Stipulationes, paritèr ac illas, quas Ipsa in se antea suscepit, teneri velle.

XXVI.

Peace is made, cause Justice to be done to the Family of *Hamilton*, concerning the Dukedom of *Chatehaut*, to the Duke of *Richmond*, concerning such requests as he has to make in *France*, as also to *Charles Douglas*, concerning certain Lands to be reclaimed by him, and to others.

XXIII.

By the mutual Consent of the Queen of *Great Britain*, and of the most Christian King, the Subjects of each Party, who were taken Prisoners during the War, shall be set at Liberty, without any Distinction or Ransom, paying such Debts, as they shall have contracted in the time of their being Prisoners.

XXIV.

It is mutually agreed, That all and singular the Conditions of the Peace made this Day between His Sacred Royal most Christian Majesty, and His Sacred Royal Majesty of *Portugal*, be confirmed by this Treaty; and Her Sacred Royal Majesty of *Great Britain* takes upon Her self the Guarranty of the same, to the end that it may be more firmly and inviolably observed.

XXV.

The Treaty of Peace made this Day between His Sacred Royal most Christian Majesty, and His Royal Highness the Duke of *Savoy*, is particularly included in this Treaty, as an Essential part of it, and is confirmed by it, in the same manner as if it were word for word inserted therein; Her Royal Majesty of *Great Britain* declaring expressly that She will be bound by the Stipulations of Security and Guarranty promised therein, as well as by those, which She has formerly taken upon Her self.

XXVI.
